2. REPORT OF THE MID-TERM CONFERENCE 2018

SOCIAL STRUCTURES, CULTURE AND INSTITUTIONS IN SOUTHERN EUROPEAN SOCIETIES

CATANIA (ITALY), 4-6 OCTOBER 2018

Dates, venue and infrastructure

The mid-term conference was held in Catania, Italy, between the 4th and the 6th of October 2018.

The venue was the Department of Social and Political Sciences (DSPS) of the University of Catania. DSPS is the only department at UNICT developing research and teaching in the fields of political, historical, social, economic and juridical sciences. DSPS hosts research and study centres covering major topics related to social sciences, ranging from public policies, migration and social services (LaPoss) to political and urban history (ISSICO, IMES), from local development (CEDOC) to history of migration (Cosmica), from EU Politics and Policies (Jean Monnet Centre) to Geography research and study (PROGEO).

The DSPS infrastructures include "Palazzo Pedagoggi", the headquarters of the department, and the "Polo Didattico", where the conference was held. It includes:

- A Conference Room (250 seats)
- 2 meeting rooms (25 seats)
- 2 classrooms (80 seats)
- A patio and corridor for secretarial, coffee breaks and materials.

On the same days, the Department hosted the mid-term conference of Research Network 26 (Sociology of Social Policy and Social Welfare) with Prof. Anneli Anttonen (University of Tampere) as the keynote, and the AIS mid-term Conference 2018.

Organization and support

The mid-term Conference 2018 was co-organized by the Department of Social and Political Sciences (University of Catania), LaPoss- University Research Centre (University of Catania) and ISVI - Research Institute of Education and Research on Social Development Problems, whose Secretariat was responsible for administrative support for registration, diffusion and web services. The Secretariat of ISVI managed the registration and payments, in addition to the list of participants, documents and certificates.

An **ad hoc website** and a **specific logo** were created for the event.. The goal of the website was to provide all necessary information (about the program, logistics, organization, and others) with real-time updates and the possibility to download the conference material.

The Organizing Committee was in charge of main arrangements and the elaboration of the programme. The Scientific Committee was responsible for the definition of the topic, evaluation and acceptance of abstracts and the overall organization of the final programme.

Call for papers

The call was issued on the 15th of May 2018 with the title "Social Structures, Culture and Institutions in Southern European Societies". The rationale of the mid-term conference is detailed in the call.

The mid-term conference required abstracts only. Full texts were optional.

The diffusion was made through the newsletters of ESA and ISVI. The call was also sent to the secretariats of the national associations and distributed among their members. The members of the board of the RN27 distributed the call among their institutions and colleagues.

The abstract submission closed on July 25th. A peer review process was organized by members of the Scientific Committee and the Organizing Committee. Two comments from two different persons were provided for each abstract. The registration closed on September the 15th. After this process, 101 papers were accepted.

Fees and events

A small fee was set to cover for basic expenses of the conference. The regular fee was € 80 (€ 45 for students). The fee for members of RN27 was € 60 (€ 35 for students). The fees included printed materials and 4 coffee breaks.

The choice of some gadgets (the bag) and the provision of the coffee break service were determined by ethical

aspects, with the active involvement of associations. As the same reasoning supported the choice of the proposed social activities (as “Walking in San Berillo: the periphery in the center”), consistent with the theme of the research network and sociological knowledge.

The social dinner was held on the evening of October 5th, with over 150 participants.

Programme

The final programme was formed by:

- an Opening Session (Welcome and introduction to the RN27 Mid-term Conference) with Prof. Eleni Nina-Pazarzi (University of Piraeus, RN27 Coordinator), Prof. Teresa Consoli (University of Catania, Executive and Local coordinator of the Mid-term Conference), and Keynote speaker Maurizio Ambrosini (University of Milan);
- 8 thematic sessions (Identities and Lifestyles; Youth, education and work; Gender; Communities and Social Spaces; Welfare; Migration; Socio-economics; Security, culture and perceptions) in 4/5 parallel rows of time slots;
- a Workshop for Publication options for participants– Book series “Southern European Societies” (Edward Elgar Publishers) Journal special issues;
- a PhD Workshop about “Publications and career strategies for PhD students”;
- a Plenary Session (AIS and ESA RN26 and RN27) with the Pro-Rector University of Catania, Director Dept. of Social and Political Sciences (Prof. Giuseppe Vecchio), Regional Order of Social Workers, and ESA Executive and Local Coordinator RN26 and RN27 (Prof.ssa Teresa Consoli);
- a Roundtable about the “Disentangling “The North”. New perspectives from Southern European societies” with Prof. Sue Scott (ESA President), Prof. Enrica Amaturò (AIS President), Prof. Anneli Anttonen (University of Tampere), Prof. Maurizio Ambrosini (University of Milan), Prof. Ingo Bode (RN26 past Coordinator) and Prof. Manuel Fernandez-Esquinas (RN27 Coordinator);
- a RN27 Business Meeting Session;
- a Closing Session.

The programme was edited and distributed widely through similar means. The edited version of the programme, including timetable, sessions and book of abstracts, are available on the website.

Participants

Finally 75 papers were presented. The papers are authored by 135 people.

107 participants registered effectively, in addition to the members of the secretariat and students that helped with the organization.

Budget

The total budget was 13.527 Euros. The expenses covered coffee breaks, photocopies and material, travel expenses and accommodation for the two keynote speakers, webpage and secretariat.

The funding from ESA was 2.360 Euros. The revenue from registration was 6.295 Euros. The University of Catania, the Dept. of Social and Political Sciences and LaPoss provided 3.372 Euros (mainly for coffee breaks and social activities). The Social Workers Order provided 1500 Euros (covering for keynote speakers’ accommodation and travel and for social dinner).

The components of the budget are detailed in the attached document.

Mid-term business meeting: issues discussed

To support the publication of another coordinated call for papers between three journals: RES, Sociologia On Line and AIS Journal, the official journals of the sociology associations of Spain, Portugal and Italy. To add also the journal of the Greek Sociological Association.

To increase the number of ESA/RN27 members.

To present a Semi-plenary together with RN34 on Sociology of Religion on “Negotiation, boundary-making and social relationships in migration processes: cultural, ethic and religious challenges in Southern European Societies” to Manchester ESA conference in 2019.

To outline the main topics of presentations of the latest mid-term conferences in order to establish the main tracks of upcoming events.

3. REPORT OF THE MANCHESTER CONFERENCE 2019

MANCHESTER (UK), 20-23 AUGUST 2019

Organization and support

Proposals were evaluated by the coordinators with the assistance of the coordination team, the members of the board of the RN27 and members of the advisory board. Each proposal was reviewed by at least two members.

Sessions were chaired by RN27 board members and other research network members.

In addition, the RN has participated in the organization of two joint sessions and one special plenary, and collaborated in the arrangements of one midday special session.

Call for papers

In addition to the general call for papers of the ESA conference, a specific and more detailed call for papers was designed and distributed (see RN27 website).

The diffusion was made through the newsletters of ESA, ISA, and the national associations of southern European countries. RN27 board members distributed the call among their institutions and colleagues.

Programme

The final programme included 7 sessions on the following topics:

- The Impact of the Crisis in Southern European Societies
- Migration and Refugee Flows
- Mobility, Work and Education in Europe
- Work and Education
- Social Inequalities and Social Welfare
- Educational Policies in Southern Europe
- Social aspects of Southern European Societies

A total of 29 presentations were discussed, with a participation of 76 researchers (see the section of the RN 27 in the Book of Abstracts of the ESA conference)

Business meeting

The BM was dedicated to discuss the results of the previous action plan, review the main issues of the RN27 and organize the elections for the next term. During the discussion of the previous action plan, the following issues were highlighted:

- The action plan was developed in most of the planned activities, with the exception of specific diffusion tools for the network (brochure, web site and newsletter).
- The members agreed on the need to strengthen the following issues: to design more carefully the communication activities, encourage membership, and distinguish more clearly the activities for PhD. students.
- The members also discussed the convenience to design a realistic action plan with specific roles and activities distributed among members of the coordination team and board.

The election was based on the presentation of candidates and discussion of future activities. Only one group of members presented a joint proposal to form a coordination team and to develop an action plan. The activities, profile of candidates and distribution of functions were discussed and voted. After checking membership of the attendants to the business meeting, the candidate coordination team and board were elected by acclamation (number of members present: 28).
